#### **Circular to Customers**

This Circular is to advise that Rob Brauer and I were appointed Voluntary Administrators of Therapy Focus on 9 October 2025 (**Administrators**).

#### Immediate objectives

As Administrators, we have assumed control of the business and assets of the Therapy Focus.

Although we are aware the appointment of Administrators may cause concern for customers and their families, we confirm that the Administrators' appointment has occurred (i) in a controlled manner, with the support of the Board and Executive Management team, and (ii) with sufficient funding available to maintain uninterrupted supply of services to its customers. These factors provide the Administration with a platform for continued stability.

As Administrators, we intend to continue trading Therapy Focus on a 'business as usual' basis while we undertake an urgent assessment to determine the best course of action, including progressing a sale of the business as a going concern and/or recapitalisation.

The Administrators will provide further updates to customers during the course of their appointment and you should continue to maintain contact with your regular point of contact at Therapy Focus.
